NOTIFICATION

In exercise of powers conferred under Sub-section (1) of Section 162 of The Electricity Act 2003, read with clause (zka) of Regulation 2(1) of the Central Electricity Authority (Measures relating to Safety & Electric Supply) Amendment Regulations, 2015, the undersigned is directed by order of the Governor to specify that the **notified voltage** for the purpose of self certification under Regulation 30 and Regulation 43 of the said Regulations shall be 650 volts.
