# West Bengal State Electricity Distribution Company Limited

## 1. INTRODUCTION

### 1.1 Background

- 1.1.1 **Department of Power, Govt. of West Bengal (Nodal Agency<sup>1</sup>)** is responsible to assess the need for long term perspective planning for generation of power and execution of power projects in the state of West Bengal. Nodal Agency looks after planning and oversees appropriate investments in the West Bengal Power sector, both in the public and private domains, and is also entrusted with the responsibilities of cohesively coordinating and dovetailing the activities of various power generation and distribution utilities in the state.

The **West Bengal State Electricity Distribution Company Limited (WBSEDCL)** (the “**Utility**”), is a State owned entity engaged in the distribution of electricity in the state of West Bengal and as part of this endeavor to ensure energy security for its populace, the Utility has decided to procure electricity on a long term basis from a “**New Greenfield 2 x 800 MW Supercritical/Ultra-Super Critical Thermal Power Unit**” to be set up within the State of West Bengal (Land identified should fall under Category C as per Ministry Of Environment, Forest And Climate Change (MOEF&CC) Notification dated 11<sup>th</sup> July 2025) and to be connected to the STU (State Transmission Utility) Network. The “**Project**” is proposed to be constructed through Public-Private Partnership (the “**PPP**”) on Design, Build, Finance, Own and Operate (the “**DBFOO**”) basis by sourcing fuel as per clause 1.2.8 (a.). The **Nodal Agency** shall be carrying out the Bidding Process on behalf of the “**Utility**”, for selection of a corporate entity(ies) as the Successful Bidder to whom the contract may be awarded for setting up of the coal based New Greenfield Thermal Power Station 2x800 MW for production of electricity and supply thereof to the **Utility** as per the terms and conditions specified in the Bidding Documents.

The term “New Greenfield 2x800 MW Supercritical/Ultra-Super Critical Thermal Power Unit,” “Coal-based Thermal Power Station,” or “Project” for the purpose of this RFQ-DBFOO shall mean unit of the generating station to be set up within the State of West Bengal, (Land identified should fall under Category C as per MOEF&CC Notification dated 11<sup>th</sup> July 2025) in accordance with the terms & conditions of the Power Supply Agreement (PSA) specified in the Bidding Documents. For the avoidance of doubt, it is clarified that construction for this purpose would mean that the Bidder has placed the order for supply of Boiler, Turbine and Generator (BTG) package after the date of Letter of Award (LoA). Brief particulars of the Project are as follows:

a.) If TPP is having IDCT then Contracted Capacity under the Power Supply Agreement will be 1508 MW and allowed Auxiliary Consumption is 5.75%. (5.75% as per CERC Tariff Regulation 24-29 for Super-critical Units with IDCT)

b.) If TPP is having NDCT then Contracted Capacity under the Power Supply Agreement will be 1516 MW and allowed Auxiliary Consumption is 5.25%. (5.25% as per CERC Tariff Regulation 24-29 for Super-critical Units with NDCT).

The Nodal Agency on behalf of the Utility intends to pre-qualify suitable Applicants (the “**Bidders**”) who will be eligible for participation in the Bid Stage, for awarding the Project through an open competitive bidding process in accordance with the procedure set out herein.

- 1.1.2 The Bidder who is issued Letter of Award (LoA) (the “**Selected Bidder**”) shall accept the LoA (the “**Successful Bidder**”). The Successful Bidder, who is either a company incorporated under the Companies Act, 1956/2013 or undertakes to incorporate as such prior to execution of the Power Supply Agreement-DBFOO (the “**Supplier**”) shall be responsible for designing, engineering, financing, procurement, construction, operation and maintenance of the power station under and in accordance with the provisions of a long term agreement for supply of Electricity (the “**Power Supply Agreement- DBFOO**” or the “**PSA- DBFOO**”) to be entered into between the Supplier and the Utility in the form provided by the Utility as part of the Bidding Documents pursuant hereto.
- 1.1.3 The scope of work will broadly include designing, financing, operation and maintenance of the Power Station and supply of power in accordance with the terms of the PSA. The Successful Bidder shall be responsible to obtain all the necessary clearances & approvals including Environment and Forest Clearance for the proposed Coal-based Thermal Power Station as applicable for the purpose of development and operation of the Project.
- 1.1.4 Omitted
- 1.1.5 The Nodal Agency on behalf of the Utility shall receive Applications pursuant to this RFQ - DBFOO in accordance with the terms set forth herein as modified, altered, amended and clarified from time to time by the Nodal Agency on behalf of the Utility, and all Applications shall be prepared and submitted in accordance with such terms on or before the date specified in Clause 1.3 for submission of Applications (the “**Application Due Date**”).

## **1.2 Brief description of Bidding Process**

- 1.2.1 The Nodal Agency on behalf of the Utility has adopted a two-stage bidding process (collectively referred to as the “**Bidding Process**”) for selection of the Bidder for award of the Project. The first stage (the “**Qualification Stage**”) of the process involves qualification (the “**Qualification**”) of interested parties/ consortia who make an Application in accordance with the provisions of this RFQ - DBFOO (the “**Applicant**”, which expression shall, unless repugnant to the context, include the Members of the Consortium). Prior to making an Application, the Applicant shall pay to the Utility a sum of **Rs. 1,60,000 (Rupees One Lakh Sixty thousand)** after adding applicable taxes as the cost of the RFQ - DBFOO process by Demand Draft/ Online Payment<sup>3</sup> in the name of “West Bengal State Electricity Distribution Company Limited” payable at Kolkata and submit the same in the office of the Utility at Kolkata or as provided for in Clause 5.1 and obtain the acknowledgement of the Demand Draft/ Online Payment. At the end of this stage, the Nodal Agency on behalf of the Utility will announce a list of suitable pre-qualified Applicants who shall be eligible for participation in the second stage of the Bidding Process including an E-Reverse Bidding as mentioned in Clause 1.2.8 (the “**Bid Stage**”) comprising Request for Proposals (the “**Request for Proposals-DBFOO**” or “**RFP-DBFOO**”).

Government of India has issued guidelines (see **Appendix-V**) for qualification of Bidders seeking to acquire stakes in any public sector enterprise through the process of disinvestment. These guidelines shall apply *mutatis mutandis* to this Bidding Process. The Nodal Agency on behalf of the Utility shall be entitled to disqualify an Applicant in accordance with the aforesaid guidelines at any stage of the Bidding Process. Applicants must satisfy themselves that they are qualified to Bid, and should give an undertaking to this effect in the form at **Appendix-I**.

- 1.2.2 All the Applicants would be able to participate in the e-Bidding events on making payment of the requisite fees as applicable to be paid to tendering portal i.e., **Telecommunications Consultants India Limited (TCIL)**.<sup>4</sup>
- 1.2.3 In the Qualification Stage, Applicants would be required to furnish all the information specified in this RFQ - DBFOO. Only those Applicants that are pre-qualified by the Nodal Agency on behalf of the Utility shall be invited to submit their Bids for the Project. The Nodal Agency on behalf of the Utility is likely to provide a comparatively short time span for submission of the Bids for the Project. The Applicants are, therefore, advised to familiarise themselves with the terms of the Model PSA - DBFOO that will govern the structure of this Project. The said Model PSA - DBFOO has been notified by the Government of India under section 63 of the Electricity Act 2003 for tariff-based bidding by the Utilities.
- 1.2.4 In the Bid Stage, the Bidders will be called upon to submit their financial offers (the "**Bids**") in **TCIL portal** in accordance with the RFP-DBFOO and other documents to be provided by the Nodal Agency on behalf of Utility (collectively the "**Bidding Documents**"). The Bidding Documents for the Project will be provided to every pre-qualified Bidder on payment to be notified during issuance of RFP. The Bid shall be valid for a period of not less than 120 days from the date specified in Clause 1.3 for submission of Bids (the "**Bid Due Date**"). In terms of the RFP-DBFOO, a Bidder will be required to deposit, along with its Bid, a Bid security of Rs. **48 Crores** (Rupees Forty Eight Crores) (the "**Bid Security**"), refundable no later than 120 (One Hundred Twenty) days from the Bid Due Date, except in the case of the Successful Bidder whose Bid Security shall be retained till it has provided a Performance Security under the PSA-DBFOO. The Bidders will have an option to provide Bid Security in the form of a demand draft or a bank guarantee acceptable to the Nodal Agency on behalf of Utility<sup>5</sup>. The demand draft shall be kept valid for a period not less than 180 (one hundred and eighty) days from the Bid Due Date, by submitting another demand draft before expiry of the existing demand draft and may be further extended as may be mutually agreed between the Nodal Agency on behalf of Utility and the Bidder from time to time. In case a bank guarantee is provided, its validity period shall not be less than 180 (one hundred and eighty) days from the Bid Due Date, inclusive of a claim period of 60 (sixty) days and may be extended as may be mutually agreed between the Nodal Agency on behalf of Utility and the Bidder from time to time. The Bid shall be summarily rejected if it is not accompanied by the Bid Security.
- 1.2.5 Generally, the Lowest Bidder shall be the selected Bidder. The remaining Bidders shall be kept in reserve and may, in accordance with the process specified in the RFP-DBFOO, be invited to match the Bid submitted by the Lowest Bidder in case such Lowest Bidder withdraws or is not selected for any reason. In the event that none of the other Bidders match the Bid of the Lowest Bidder, the Nodal Agency

on behalf of the Utility may, in its discretion, may invite fresh Bids from the remaining Bidders or annul the Bidding Process, as may deemed fit.

- 1.2.6 During the Bid Stage, Bidders are invited to examine the Project in greater detail, and to carry out, at their cost, such studies as may be required for submitting their respective Bids for award of the contract including implementation of the Project.
- 1.2.7 As part of the Bidding Documents, the Nodal Agency on behalf of the Utility will provide a draft PSA-DBFOO and other information pertaining/ relevant to the Project available with it.
- 1.2.8 Bids will be invited for the Project on the basis of a tariff to be offered by a Bidder for production and supply of electricity from the proposed New Greenfield 2 x 800 MW coal based thermal power station, in accordance with the terms of the draft PSA-DBFOO forming part of the Bidding Documents. For the purposes of bidding hereunder, the **Fixed Charge** and **Fuel Charge** will constitute the tariff for the Power Station (the “**Tariff**”). The element of coal transportation and transit losses may vary from case to case and shall also form part of the Fuel Charge by way of adjustment. The contract period shall be pre-determined and will be indicated in the draft PSA-DBFOO.

Explanation

(a) Since the Bidder is expected to source linkage coal from Coal India Limited (the “**CIL**”) or a subsidiary thereof from the Allocated Coal Linkage as per Revised SHAKTI Policy arranged by the Nodal Agency on behalf of the Utility, the cost of Fuel which shall be included in the Fuel Charge shall be a “pass through” in accordance with the terms of the PSA- DBFOO. However, the element of coal transportation and transit losses may vary from case to case and shall affect the Fuel Charge offered by each Bidder. The Bid for the Project shall, therefore, comprise the Fixed Charge and Fuel Charge, which shall be specified separately, and the Bidder seeking the lowest Tariff shall be the Selected Bidder. Also, while quoting the tariff the bidder should take cognizance of the fact that the Base Fixed Charge shall not be more than 70% of the Tariff and the Base Fuel Charge shall not be more than 50% of the Tariff.

The Nodal Agency on behalf of the Utility shall follow an E-Reverse Bidding process through **TCIL portal**. The Project shall be awarded to the Bidder quoting the lowest Tariff in E-Reverse Auction Stage. Applicable Steps to be followed on the E-Reverse Bidding Stage has been mentioned under **Appendix-VIII**.

In this RFQ - DBFOO, the term “**Lowest Bidder**” shall mean the Bidder who is offering the lowest Tariff after E-Reverse Bidding Process.

- 1.2.9 The Selected Bidder shall surrender the proportionate quantity of any existing Letter of Assurance /Fuel Supply Agreement to the supplier of the coal, not being the Letter of Assurance/ Fuel Supply Agreement arranged by the Utility, corresponding to the tenure of the Letter of Assurance /Fuel Supply Agreement arranged by the Utility. Further and other details of the process to be followed at the Bid Stage and the terms thereof will be spelt out in the Bidding Documents.
- 1.2.10 Any queries or request for additional information concerning this RFQ - DBFOO shall be submitted in writing by speed post/ courier/ special messenger and e-mail attaching the queries in Microsoft word file so as to reach the officer designated in Clause 2.13.3 by the specified date. The envelopes/ communications shall clearly bear the following identification/ title:

**"Queries/ Request for Additional Information: RFQ - DBFOO for Setting Up New Greenfield 2x800 MW Supercritical / Ultra Supercritical Thermal Power Plant Unit".**

## 2. INSTRUCTIONS TO APPLICANTS

### A. GENERAL

#### 2.1 Scope of Application

- 2.1.1 The Nodal Agency on behalf of the Utility wishes to receive Applications for Qualification in order to pre-qualify experienced and capable Applicants for the Bid Stage.
- 2.1.2 Pre-qualified Applicants may be subsequently invited to submit the Bids for the Project.

#### 2.2 Eligibility of Applicants

- 2.2.1 For determining the eligibility of Applicants for their pre-qualification hereunder, the following shall apply:

(a) The Applicant for pre-qualification may be a single entity-or a group of entities (the “**Consortium**”), coming together to implement the Project. However, no applicant applying individually or as a member of a Consortium, as the case may be, can be member of another Applicant. The term Applicant used herein would apply to both a single entity and a Consortium.

(b) An Applicant may be a natural person, private entity, government-owned entity, or any combination of them with a formal intent to enter into an agreement or under an existing agreement to form a Consortium. A Consortium shall be eligible for consideration subject to the conditions set out in Clause 2.2.6 below.

(c) An Applicant shall not have a conflict of interest (the “**Conflict of Interest**”) that affects the Bidding Process. Any Applicant found to have a Conflict of Interest shall be disqualified<sup>6</sup>. An Applicant shall be deemed to have a Conflict of Interest affecting the Bidding Process, if:

- (i) intermediary in any other person (the “Subject Person”) shall be taken into account for computing the shareholding of such controlling person in the Subject Person; and (bb) subject always to sub-clause (aa) above, where a person does not exercise control over an intermediary, which has shareholding in the Subject Person, the computation of indirect shareholding of such person in the Subject Person shall be undertaken on a proportionate basis; provided, however, that no such shareholding shall be reckoned under this sub-clause (bb) if the shareholding of such person in the intermediary is less than 26% of the subscribed and paid up equity shareholding of such intermediary; or
- (ii) a constituent of such Applicant is also a constituent of another Applicant; or
- (iii) such Applicant, or any Associate thereof receives or has received any direct or indirect subsidy, grant, concessional loan or subordinated debt

from any other Applicant, or any Associate thereof or has provided any such subsidy, grant, concessional loan or subordinated debt to any other Applicant, its Member or any Associate thereof; or

- (iv) such Applicant has the same legal representative for purposes of this Application as any other Applicant; or
- (v) such Applicant, or any Associate thereof has a relationship with another Applicant, or any Associate thereof, directly or through common third party/ parties, that puts either or both of them in a position to have access to each other's information about, or to influence the Application of either or each other; or
- (vi) such Applicant, or any Associate thereof has participated as a consultant to the Nodal Agency on behalf of the Utility in the preparation of any documents, design, or technical specifications of the Project.

(d) An Applicant shall be liable for disqualification if any legal, financial, or technical adviser of the Nodal Agency on behalf of the Utility in relation to the Project is engaged by the Applicant, its Member, or any Associate thereof, as the case may be, in any manner for matters related to or incidental to the Project. For the avoidance of doubt, this disqualification shall not apply where such adviser was engaged by the Applicant, its Member or Associate in the past but its assignment expired or was terminated prior to the Application Due Date. Nor will this disqualification apply where such adviser is engaged after a period of 3 (three) years from the date of commercial operation of the Project.

*Explanation:* In case an Applicant is a Consortium, then the term Applicant as used in this Clause 2.2.1, shall include each Member of such Consortium.

- (e) Other eligibility conditions shall include the following:
  - (i) Omitted
  - (ii) Only Applicants who agree and undertake to procure the boilers, turbines, and generators of the proposed Project from manufacturing facilities situated in India and are entities that are owned and operated in India by an Indian company, a foreign company, or a joint venture between an Indian and foreign company, shall be eligible hereunder.
  - (iii) Applicant/Consortium Member or any of its Associates should not have been referred to National Company Law Tribunal (NCLT) and proceedings are pending in such Tribunal.

2.2.2 To be eligible for pre-qualification, an Applicant shall fulfill the following conditions of eligibility:

- (A) **Technical Capacity:** For demonstrating technical capacity and experience (the “**Technical Capacity**”), the Applicant shall, over the past 5 (five) financial years preceding the Application Due Date, have:
  - (i) paid for, or received payments for, construction of Eligible Project(s); and/ or
  - (ii) paid for development of Eligible Project(s) in Category 1 and /or Category 2 specified in Clause 3.2.1; and/ or

- (iii) collected and appropriated revenues from Eligible Project(s) in Category 1 and /or Category 2 specified in Clause 3.2.1,

such that the sum total of the above is more than **Rs. 8000 Crores (Rupees Eight Thousand Crores)** (the “**Threshold Technical Capacity**”).

- (B) **Financial Capacity:** The Applicant shall have a minimum Net Worth (the “**Financial Capacity**”) **equivalent to Rs. 2400 Crores (Rupees Twenty Four Hundred Crores)** at the close of the preceding financial year.

In case of a Consortium, the combined technical capacity and net worth of those Members, who shall have an equity share of at least 26% (twenty six per cent) each in the SPV, should satisfy the above conditions of eligibility; provided that each such Member shall, for a period of 2 (two) years from the date of commercial operation of the Project, hold equity share capital not less than: (i) 26% (twenty six per cent) of the subscribed and paid up equity of the SPV; and (ii) 5% (five per cent) of the Total Project Cost<sup>7</sup> as per the PSA-DBFOO.

The Applicant or any of its Affiliates (as defined in the Company’s Act) must not have been declared insolvent and/or undergone any insolvency proceeding over a consideration period of past 5 completed financial years preceding the Appointed Date & the Applicant must not have been blacklisted by any Government institution/ Statutory Authority/ PSU in past 5 completed financial years preceding the Appointed Date.

- 2.2.3 **O&M Experience:** The Applicant shall either enter into an agreement for entrusting its operation & maintenance (O&M) obligations to an entity having the requisite experience or undertake O&M through qualified and experienced staff of its own.

- 2.2.4 The Applicants shall enclose with its Application, to be submitted as per the format at Appendix-I, complete with its Annexes, the following<sup>8</sup>:

- (i) Certificate(s) from statutory auditors/ practicing Chartered Accountant of the Applicant or its Associate or the concerned client(s) stating the payments made/ received or works commissioned, as the case may be, during the past 5 years in respect of the projects specified in paragraph 2.2.2 (A) above. In case a particular job/ contract has been jointly executed by the Applicant (as part of a consortium), it should further support its claim for the share in work done for that particular job/ contract by producing a certificate from its statutory auditor or the client; and
- (ii) Certificate(s) from statutory auditors/ practicing Chartered Accountant of the Applicant or its Associates or, specifying the Net Worth of the Applicant, as at the close of the preceding financial year, and also specifying that the methodology adopted for calculating such Net Worth conforms to the provisions of this Clause 2.2.4 (ii). For the purposes of this RFQ - DBFOO, net worth (the “**Net Worth**”) shall mean the sum of subscribed

and paid-up equity and reserves from which shall be deducted the sum of revaluation reserves, miscellaneous expenditure not written off and reserves not available for distribution to equity shareholders.

- 2.2.5 The Applicant should submit a Power of Attorney as per the format at Appendix-II, authorising the signatory of the Application to commit the Applicant. In the case of a Consortium, the Members should submit a Power of Attorney in favour of the Lead Member as per format at Appendix-III.
- 2.2.6 Where the Applicant is a single entity, it may be required to form an appropriate Special Purpose Vehicle, incorporated under the Indian Companies Act, 1956/2013 (the “**SPV**”), to execute the PSA-DBFOO and implement the Project. In case the Applicant is a Consortium, it shall, in addition to forming an SPV, comply with the following additional requirements:
- (a) Number of members in a consortium shall not exceed **4 (four)**;
  - (b) Subject to the provisions of sub-clause (a) above, the Application should contain the information required for each member of the Consortium;
  - (c) Members of the Consortium shall nominate one member as the lead member (the “**Lead Member**”), who shall have an equity share holding of at least 26% (twenty-six per cent) of the paid up and subscribed equity of the SPV and who shall have prior experience and / engaged into Thermal Power Generation business. The nomination(s) shall be supported by a Power of Attorney, as per the format at Appendix-III, signed by all the other members of the Consortium;
  - (d) The Application should include a brief description of the roles and responsibilities of individual members, particularly with reference to financial, technical, and O&M obligations;
  - (e) An individual Applicant cannot at the same time be member of a Consortium applying for pre-qualification. Further, a member of a particular Applicant Consortium cannot be member of any other Applicant Consortium applying for pre-qualification;
  - (f) The members of a Consortium shall form an appropriate SPV to execute the Project, if awarded to the Consortium;
  - (g) Members of the Consortium shall enter into a binding Joint Bidding Agreement, substantially in the form specified at Appendix-IV (the “**Joint Bidding Agreement**”), for the purpose of making the Application and submitting a Bid in the event of being pre-qualified. The Joint Bidding Agreement, to be submitted along with the Application, shall, *inter alia*:
    - i. convey the intent to form an SPV with shareholding/ ownership equity commitment(s) in accordance with this RFQ - DBFOO, which would enter into the PSA-DBFOO and subsequently perform all the obligations of the Supplier in terms of the PSA-DBFOO, in case the contract to undertake the Project is awarded to the Consortium;
    - ii. clearly outline the proposed roles and responsibilities, if any, of each member;



- iii. commit the minimum equity stake to be held by each member;
  - iv. commit that each of the members, whose experience will be evaluated for the purposes of this RFQ - DBFOO , shall subscribe to 26% (twenty six per cent) or more of the paid up and subscribed equity of the SPV and shall further commit that each such member shall, for a period of 2 (two) years from the date of commercial operation of the Project, hold equity share capital not less than: (i) 26% (twenty six per cent) of the subscribed and paid up equity share capital of the SPV and (ii) 5% (five per cent) of the Total Project Cost as per the Power Supply Agreement-DBFOO.
  - v. members of the Consortium undertake that they shall collectively hold at least 51% (fifty-one per cent) of the subscribed and paid up equity of the SPV at all times until the first anniversary of the commercial operation date of the Project; and
  - vi. include a statement to the effect that all members of the Consortium shall be liable jointly and severally for all obligations of the Supplier in relation to the Project until the Financial Close of the Project is achieved in accordance with the PSA-DBFOO; and
- (h) except as provided under this RFQ - DBFOO and the Bidding Documents, there shall not be any amendment to the Joint Bidding Agreement without the prior written consent of the Nodal Agency on behalf of the Utility.
- 2.2.7 Any entity which has been barred by the Central/ State Government, or any entity controlled by it, from participating in any project (BOT or otherwise), and the bar subsists as on the date of Application, would not be eligible to submit an Application, either individually or as member of a Consortium.
- 2.2.8 An Applicant including any Consortium Member or Associate should, in the last 3 (three) years, have neither failed to perform on any contract, as evidenced by imposition of a penalty by an arbitral or judicial authority or a judicial pronouncement or arbitration award against the Applicant, Consortium Member or Associate, as the case may be, nor has been expelled from any project or contract by any public entity nor have had any contract terminated by any public entity for breach by such Applicant, Consortium Member or Associate. Provided, however, that where an Applicant claims that its disqualification arising on account of any cause or event specified in this Clause 2.2.8 is such that it does not reflect (a) any malfeasance on its part in relation to such cause or event; (b) any willful default or patent breach of the material terms of the relevant contract; (c) any fraud, deceit or misrepresentation in relation to such contract; or (d) any rescinding or abandoning of such contract, it may make a representation to this effect to the Nodal Agency on behalf of the Utility for seeking a waiver from the disqualification hereunder and the Nodal Agency on behalf of the Utility may, in its sole discretion and for reasons to be recorded in writing, grant such waiver if it is satisfied with the grounds of such representation and is further satisfied that such waiver is not in any manner likely to cause a material adverse impact on the Bidding Process or on the implementation of the Project.
- 2.2.9 In computing the Technical Capacity and Net Worth of the Applicant/ Consortium Members under Clauses 2.2.2, 2.2.4 and 3.2, the Technical Capacity and Net Worth of their respective Associates would also be eligible hereunder.

For purposes of this RFQ - DBFOO, Associate means, in relation to the Applicant/ Consortium Member, a person who controls, is controlled by, or is under the common control with such Applicant/ Consortium Member (the “**Associate**”). As used in this definition, the expression “control” means, with respect to a person which is a company or corporation, the ownership, directly or indirectly, of more than 50% (fifty per cent) of the voting shares of such person, and with respect to a person which is not a company or corporation, the power to direct the management and policies of such person by operation of law.

2.2.10 The following conditions shall be adhered to while submitting an Application:

- (a) Applicants should attach clearly marked and referenced continuation sheets in the event that the space provided in the prescribed forms in the Annexes is insufficient. Alternatively, Applicants may format the prescribed forms making due provision for incorporation of the requested information;
- (b) information supplied by an Applicant (or other constituent Member if the Applicant is a Consortium) must apply to the Applicant, Member or Associate named in the Application and not, unless specifically requested, to other associated companies or firms. Invitation to submit Bids will be issued only to Applicants whose identity and/ or constitution is identical to that at pre-qualification;
- (c) in responding to the pre-qualification submissions, Applicants should demonstrate their capabilities in accordance with Clause 3.1 below; and
- (d) in case the Applicant is a Consortium, each Member should substantially satisfy the pre-qualification requirements to the extent specified herein.

2.2.11 While Qualification is open to persons from any country, the following provisions shall apply:

- (a) Where, on the date of the Application, 25% (twenty-five per cent) or more of the aggregate issued, subscribed, and paid up equity share capital in an Applicant or its Member is held by persons resident outside India or where an Applicant or its Member is controlled by persons resident outside India; or
- (b) if at any subsequent stage after the date of the Application, there is an acquisition of 25% (twenty-five per cent) or more of the aggregate issued, subscribed, and paid up equity share capital or control, by persons resident outside India, in or of the Applicant or its Member;

then the Qualification of such Applicant or in the event described in sub clause (b) above, the continued Qualification of the Applicant shall be subject to approval of the Nodal Agency on behalf of the Utility from national security and public interest perspective. The decision of the Nodal Agency on behalf of the Utility in this behalf shall be final and conclusive and binding on the Applicant.

The holding or acquisition of equity or control, as above, shall include direct or indirect holding/ acquisition, including by transfer, of the direct or indirect legal or beneficial ownership or control, by persons acting for themselves or in concert and in determining such holding or acquisition, the Nodal Agency on behalf of the Utility shall be guided by the principles, precedents and definitions contained in the Securities and Exchange Board of India (Substantial Acquisition of Shares and Takeovers) Regulations, 1997, or any substitute thereof, as in force on the date of such acquisition.

The Applicant shall promptly inform the Nodal Agency on behalf of the Utility of any change in the shareholding, as above, and failure to do so shall render the Applicant liable for disqualification from the Bidding Process.

- 2.2.12 Notwithstanding anything to the contrary contained herein, in the event that the Application Due Date falls within three months of the closing of the latest financial year of an Applicant, it shall ignore such financial year for the purposes of its Application and furnish all its information and certification with reference to the 5 (five) years or 1 (one) year, as the case may be, preceding its latest financial year. For the avoidance of doubt, financial year shall, for the purposes of an Application hereunder, mean the accounting year followed by the Applicant in the course of its normal business.

### **2.3 Change in Composition of the Consortium**

- 2.3.1 Change in the composition of a Consortium will not be permitted by the Nodal Agency on behalf of the Utility during the Qualification Stage.
- 2.3.2 Where the Bidder<sup>9</sup> is a Consortium, change in the composition of a Consortium may be permitted by the Nodal Agency on behalf of the Utility during the Bid Stage, only where:
- (a) the application for such change is made no later than 15 (fifteen) days prior to the Bid Due Date; and
  - (b) the Lead Member continues to be the Lead Member of the Consortium.
  - (c) the substitute is at least equal, in terms of Technical Capacity, to the Consortium Member who is sought to be substituted and the modified Consortium shall continue to meet the pre-qualification criteria for Applicants; and
  - (d) the new Member(s) expressly adopt(s) the Application already made on behalf of the Consortium as if it were a party to it originally and is not an Applicant/Member/Associate of any other Consortium bidding for this Project.
- 2.3.3 Approval for change in the composition of a Consortium shall be at the sole discretion of the Nodal Agency on behalf of the Utility and must be approved by the Utility in writing.
- 2.3.4 The modified/ reconstituted Consortium shall submit a revised Joint Bidding Agreement before the Bid Due Date.
- 2.3.5 Notwithstanding anything to the contrary contained in sub-clause (c) (i) of Clause 2.2.1, an Applicant may, within 10 (ten) days after the Application Due Date, remove from its Consortium any Member who suffers from a Conflict of Interest, and such removal shall be deemed to cure the Conflict of Interest arising in respect thereof.

### **2.4 Number of Applications and costs thereof**

- 2.4.1 No Applicant shall submit more than one Application for the Project. An applicant

applying individually or as a member of a Consortium shall not be entitled to submit another Application either individually or as a member of any Consortium, as the case may be.

- 2.4.2 The Applicants shall be responsible for all of the costs associated with the preparation of their Applications and their participation in the Bid Process. The Utility will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of the Bidding Process.

## **2.5 Site visit and verification of information**

Applicants are encouraged to submit their respective Applications after familiarizing themselves with the information and physical conditions relevant to the Project, including the transmission capacity, the site conditions, location, surroundings, climate, availability of power, water and other utilities for construction, access to site, handling and storage of materials, weather data, applicable laws and regulations, and any other matter considered relevant by them. The site visit shall be followed by brief presentation from the bidders which shall be concluded as per timeline outlined in Clause 1.3. Nodal Agency on behalf of the Utility seeks necessary input and observations as well as any additional relevant points, during the presentation following the site visit.

## **2.6 Acknowledgement by Applicant**

- 2.6.1 It shall be deemed that by submitting the Application, the Applicant has:
- (a) made a complete and careful examination of the RFQ - DBFOO; and
  - (b) received all relevant information requested from the Nodal Agency on behalf of the Utility; and
  - (c) accepted the risk of inadequacy, error or mistake in the information provided in the RFQ - DBFOO or furnished by or on behalf of the Nodal Agency on behalf of the Utility relating to any of the matters referred to in Clause 2.5 above; and
  - (d) agreed to be bound by the undertakings provided by it under and in terms hereof.
- 2.6.2 The Nodal Agency on behalf of the Utility shall not be liable for any omission, mistake or error in respect of any of the above or on account of any matter or thing arising out of or concerning or relating to the RFQ - DBFOO or the Bidding Process, including any error or mistake therein or in any information or data given by the Utility.

## **2.7 Right to accept or reject any or all Applications/ Bids**

- 2.7.1 Notwithstanding anything contained in this RFQ - DBFOO, the Nodal Agency on behalf of the Utility reserves the right to accept or reject any Application and to annul the Bidding Process and reject all Applications/ Bids, at any time without any liability or any obligation for such acceptance, rejection or annulment, and without assigning any reasons therefore. In the event that the Nodal Agency on behalf of the Utility rejects or annuls all the Bids, it may, in its discretion, invite all eligible Bidders to submit fresh Bids hereunder.
- 2.7.2 The Nodal Agency on behalf of the Utility reserves the right to reject any Application and/ or Bid if:

- (a) at any time, a material misrepresentation is made or uncovered, or
- (b) the Applicant does not provide, within the time specified by the Nodal Agency on behalf of the Utility, the supplemental information sought by the Nodal Agency on behalf of the Utility for evaluation of the Application.

If the Applicant/Bidder is a Consortium, then the entire Consortium may be disqualified/ rejected. If such disqualification/ rejection occurs after the Bids have been opened and the Lowest Bidder gets disqualified/ rejected, then the Nodal Agency on behalf of the Utility reserves the right to:

- a) invite the remaining Bidders to match the Lowest Bidder/ submit their Bids in accordance with the RFP-DBFOO; or
- b) take any such measure as may be deemed fit in the sole discretion of the Nodal Agency on behalf of the Utility, including annulment of the Bidding Process.

2.7.3 In case it is found during the evaluation or at any time before signing of the PSA-DBFOO or after its execution and during the period of subsistence thereof, including the contract thereby granted by the Nodal Agency on behalf of the Utility ,that one or more of the pre- qualification conditions have not been met by the Applicant, or the Applicant has made material misrepresentation or has given any materially incorrect or false information, the Applicant shall be disqualified forthwith if not yet appointed as the Supplier either by issue of the LOA or entering into of the PSA-DBFOO, and if the Applicant/SPV has already been issued the LOA or has entered into the PSA-DBFOO, as the case may be, the same shall, notwithstanding anything to the contrary contained therein or in this RFQ - DBFOO, be liable to be terminated, by a communication in writing by the Nodal Agency to the Applicant, without the Nodal Agency on behalf of the Utility being liable in any manner whatsoever to the Applicant and without prejudice to any other right or remedy which the Nodal Agency on behalf of the Utility may have under this RFQ - DBFOO , the Bidding Documents, the PSA-DBFOO or under applicable law.

2.7.4 The Nodal Agency on behalf of the Utility reserves the right to verify all statements, information and documents submitted by the Applicant in response to the RFQ - DBFOO. Any such verification or lack of such verification by the Nodal Agency on behalf of the Utility shall not relieve the Applicant of its obligations or liabilities hereunder nor will it affect any rights of the Nodal Agency on behalf of the Utility thereunder.

## **2.9 Clarifications**

- 2.9.1 Applicants requiring any clarification on the RFQ - DBFOO may notify the Nodal Agency in writing by speed post/ courier/ special messenger / by e-mail attaching the queries in Microsoft word file in accordance with Clause 1.2.10. They should send in their queries before the date specified in the schedule of Bidding Process contained in Clause 1.3. The Nodal Agency on behalf of Utility shall endeavor to respond to the queries within the period specified therein, but no later than 7 (seven) days prior to the Application Due Date. The responses will be sent by e-mail. The Nodal Agency on behalf of Utility will forward all the queries and its responses thereto, to all purchasers of the RFQ - DBFOO without identifying the source of queries.
- 2.9.2 The Nodal Agency on behalf of the Utility shall endeavour to respond to the questions raised or clarifications sought by the Applicants. However, the Nodal Agency on behalf of the Utility reserves the right not to respond to any question or provide any clarification, in its sole discretion, and nothing in this Clause shall be taken or read as compelling or requiring the Nodal Agency on behalf of the Utility to respond to any question or to provide any clarification.
- 2.9.3 The Nodal Agency on behalf of the Utility may also on its own motion, if deemed necessary, issue interpretations and clarifications to all Applicants. All clarifications and interpretations issued by the Nodal Agency on behalf of the Utility shall be deemed to be part of the RFQ - DBFOO. Verbal clarifications and information given by Nodal Agency on behalf of the Utility or its employees or representatives shall not in any way or manner be binding on the Nodal Agency/Utility.

## **2.10 Amendment of RFQ - DBFOO**

- 2.10.1 At any time prior to the deadline for submission of Application, the Nodal Agency on behalf of the Utility may, for any reason, whether at its own initiative or in response to clarifications requested by an Applicant, modify the RFQ - DBFOO by the issuance of Addenda.
- 2.10.2 Any Addendum thus issued will be sent in writing to all those who have purchased the RFQ - DBFOO.
- 2.10.3 In order to afford the Applicants a reasonable time for taking an Addendum into account, or for any other reason, the Nodal Agency on behalf of the Utility may, in

its sole discretion, extend the Application Due Date<sup>10</sup>.

## **C. PREPARATION AND SUBMISSION OF APPLICATION**

### **2.11 Language**

The Application and all related correspondence and documents in relation to the Bidding Process shall be in English language. Supporting documents and printed literature furnished by the Applicant with the Application may be in any other language provided that they are accompanied by translations of all the pertinent passages in the English language, duly authenticated and certified by the Applicant. Supporting materials, which are not translated into English, may not be considered. For the purpose of interpretation and evaluation of the Application, the English language translation shall prevail.

### **2.12 Format and signing of Application**

- 2.12.1 The Applicant shall provide all the information sought under this RFQ - DBFOO. The Nodal Agency on behalf of the Utility will evaluate only those Applications that are received in the required formats and complete in all respects. Incomplete and /or conditional Applications shall be liable to rejection.
- 2.12.2 The Applicant shall prepare 1 (one) original set of the Application (together with the documents required to be submitted pursuant to this RFQ - DBFOO) and clearly marked as “ORIGINAL”.
- 2.12.3 The Application shall be typed or written in indelible ink it shall be signed by the authorized signatory of the Applicant who shall also initial each page of the Application (including each Appendix and Annex) in blue ink. In case of printed and published documents, only the cover shall be initialed. All the alterations, omissions, additions, or any other amendments made to the Application shall be initialed by the person(s) signing the Application. The Application shall contain page numbers and shall be bound together in a manner that does not allow replacement of any page.

### **2.13 Sealing and Marking of Applications**

- 2.13.1 The Applicant shall submit the Application in the format specified at Appendix-I, together with the documents specified in Clause 2.13.2, and seal it in an envelope and mark the envelope as “APPLICATION”. The envelope shall then be sealed in an outer envelope which shall also be marked in accordance with Clauses 2.13.2 and 2.13.3.

- 2.13.2 The envelope shall contain:

- i. Application in the prescribed format (Appendix-I) along with Annexes and supporting documents;
- ii. Power of Attorney for signing the Application as per the format at Appendix-II;
- iii. if applicable, the Power of Attorney for Lead Member of Consortium as per the format at Appendix-III;
- iv. copy of the Joint Bidding Agreement, in case of a Consortium, substantially in the format at Appendix-IV;
- v. copy of Memorandum and Articles of Association, if the Applicant is a body corporate, and if a partnership then a copy of its partnership deed;
- vi. copies of Applicant’s duly audited balance sheet and profit and loss

- account for the preceding five years; and If the Applicant is a Consortium, the duly audited balance sheets and profit and loss accounts for the preceding five completed financial years for all Consortium Members must be provided.
- vii. Omitted.
- viii. The copy of the receipt for payment of the cost of RFQ-DBFOO.

The envelope shall clearly bear the following identification: “**Application for Qualification for Setting Up New Greenfield 2x800 MW Supercritical / Ultra Supercritical Thermal Power Plant Unit**”.

and shall clearly indicate the name and address of the Applicant. In addition, the Application Due Date should be indicated on the right-hand corner of the envelope.

These hard copies must arrive at the aforementioned address within 10 days of the Application's opening, as specified in Clause 1.3 of this RFQ. Applicants are advised that if there is any discrepancy between the documents uploaded online to the **TCIL portal** and the hard copies submitted in accordance with Clause 2.13.3, the online documents will take precedence.

- 2.13.4 If the Application is not uploaded and digitally signed as instructed above the Nodal Agency on behalf of the Utility assumes no responsibility for the misplacement or premature opening of the contents of the Application and consequent losses, if any, suffered by the Applicant.
- 2.13.5 Applications submitted by fax or e-mail shall not be entertained and shall be rejected. After uploading of the Applications to the **TCIL portal** as per the RFQ and digitally signing it, the same must be duly submitted in the portal.

**2.14 Application Due Date**

- 2.14.1 Applications should be submitted **latest by 12:00 hours IST** on the Application Due Date, at the address provided in Clause 2.13.3 in the manner and form as detailed in this RFQ - DBFOO. A receipt thereof should be obtained from the person specified in Clause 2.13.3.
- 2.14.2 The Nodal Agency on behalf of the Utility may, in its sole discretion, extend the Application Due Date by issuing an Addendum in accordance with Clause 2.10 uniformly for all Applicants.

**2.15 Late Applications**

Applications received by the Nodal Agency on behalf of the Utility after the specified time on the Application Due Date shall not be eligible for consideration and shall be summarily rejected.



## **2.16 Modifications/ substitution/ withdrawal of Applications**

- 2.16.1 The Applicant may modify, substitute, or withdraw its Application after submission, provided that written notice of the modification, substitution or withdrawal is received by the Nodal Agency on behalf of the Utility prior to the Application Due Date. No Application shall be modified, substituted, or withdrawn by the Applicant on or after the Application Due Date.
- 2.16.2 The modification, substitution or withdrawal notice shall be prepared, sealed, marked, and delivered in accordance with Clause 2.13, with the envelopes being additionally marked “MODIFICATION”, “WITHDRAWAL”, as appropriate.
- 2.16.3 Any alteration/ modification in the Application or additional information supplied subsequent to the Application Due Date, unless the same has been expressly sought for by the Nodal Agency on behalf of the Utility, shall be disregarded.

## **D. EVALUATION PROCESS**

### **2.17 Opening and Evaluation of Applications**

- 2.17.1 The Nodal Agency on behalf of the Utility shall open the Applications on **TCIL portal at 14:00 hours IST** on the Application Due Date.
- 2.17.2 Applications for which a notice of withdrawal has been submitted in accordance with Clause 2.16 shall not be opened and payments if any made shall be non-refundable in accordance with Clause 1.2.2.
- 2.17.3 The Nodal Agency on behalf the Utility will subsequently examine and evaluate Applications in accordance with the provisions set out in Section 3.
- 2.17.4 Applicants are advised that pre-qualification of Applicants will be entirely at the discretion of the Nodal Agency on behalf the Utility. Applicants will be deemed to have understood and agreed that no explanation or justification on any aspect of the Bidding Process or selection will be given.
- 2.17.5 Any information contained in the Application shall not in any way be construed as binding on the Nodal Agency on behalf of the Utility, its agents, successors or assigns, but shall be binding against the Applicant if the Project is subsequently awarded to it on the basis of such information.
- 2.17.6 The Nodal Agency on behalf of the Utility reserves the right not to proceed with the Bidding Process at any time without notice or liability and to reject any or all Application(s) without assigning any reasons.
- 2.17.7 If any information furnished by the Applicant is found to be incomplete, or contained in formats other than those specified herein, the Nodal Agency on behalf of the Utility may, in its sole discretion, exclude the relevant project from computation of the Experience Score of the Applicant.
- 2.17.8 In the event that an Applicant claims credit for an Eligible Project, and such claim is determined by the Nodal Agency on behalf of the Utility as incorrect or erroneous, the Nodal Agency on behalf of the Utility shall reject such claim and exclude the

same from computation of the Experience Score, and may also, while computing the aggregate Experience Score of the Applicant, make a further deduction equivalent to the claim rejected hereunder. Where any information is found to be patently false amounting to a material misrepresentation, the Nodal Agency on behalf of the Utility reserves the right to reject the Application and/ or Bid in accordance with the provisions of Clauses 2.7.2 and 2.7.3.

## **2.18 Confidentiality**

Information relating to the examination, clarification, evaluation, and recommendation for the pre-qualified Applicants shall not be disclosed to any person who is not officially concerned with the process or is not a retained professional advisor advising the Nodal Agency on behalf of the Utility in relation to, or matters arising out of, or concerning the Bidding Process. The Nodal Agency on behalf of the Utility will treat all information, submitted as part of Application, in confidence and will require all those who have access to such material to treat the same in confidence. The Nodal Agency on behalf of the Utility may not divulge any such information unless it is directed to do so by any statutory entity that has the power under law to require its disclosure or is to enforce or assert any right or privilege of the statutory entity and/ or the Nodal Agency on behalf of the Utility or as may be required by law or in connection with any legal process.

## **2.19 Tests of responsiveness**

2.19.1 Prior to evaluation of Applications, the Nodal Agency on behalf of the Utility shall determine whether each Application is responsive to the requirements of the RFQ - DBFOO. An Application shall be considered responsive if:

- a) it is uploaded on TCIL portal as per format at Appendix-I.
- b) it is uploaded on TCIL portal received by the Application Due Date including any extension thereof pursuant to Clause 2.14.2;
- c) it is signed, sealed, bound together in hard cover, and marked as stipulated in Clauses 2.12 and 2.13;
- d) it is accompanied by the Power of Attorney as specified in Clause 2.2.5, and in the case of a Consortium, the Power of Attorney as specified in Clause 2.2.6 (c);
- e) it contains all the information and documents (complete in all respects) as requested in this RFQ - DBFOO;
- f) it contains information in formats same as those specified in this RFQ - DBFOO;
- g) it contains certificates from its statutory auditors<sup>11</sup> in the formats specified at Appendix-I of the RFQ - DBFOO for each Eligible Project;
- h) it contains an attested copy of the receipt of the Utility towards the cost of the RFQ - DBFOO process as specified in Clause 1.2.1;
- i) it is accompanied by the Joint Bidding Agreement (for Consortium), specific to the Project, as stipulated in Clause 2.2.6(g);
- j) it does not contain any condition or qualification; and
- k) it is not non-responsive in terms hereof.

2.19.2 The Nodal Agency on behalf of the Utility reserves the right to reject any Application which is non-responsive and no request for alteration, modification, substitution, or

withdrawal shall be entertained by the Nodal Agency on behalf of the Utility in respect of such Application. Provided, however, that the Nodal Agency on behalf of the Utility may, in its discretion, allow the Applicant to rectify any infirmities or omissions if the same do not constitute a material modification of the Application by submission of the information, clarification and documents directly to the Nodal Agency on behalf of the Utility as requested in writing by the Nodal Agency on behalf of the Utility in terms of Clause 2.20 of RFQ-DBFOO.

## **2.20 Clarifications**

- 2.20.1 To facilitate evaluation of Applications, the Nodal Agency on behalf of the Utility may, at its sole discretion, seek clarifications from any Applicant regarding its Application. Such clarification(s) shall be provided within the time specified by the Nodal Agency on behalf of the Utility for this purpose. Any request for clarification(s) and all clarification(s) in response thereto shall be in writing.
- 2.20.2 If an Applicant does not provide clarifications sought under Clause 2.20.1 above within the prescribed time, its Application shall be liable to be rejected. In case the Application is not rejected, the Nodal Agency on behalf of the Utility may proceed to evaluate the Application by construing the particulars requiring clarification to the best of its understanding, and the Applicant shall be barred from subsequently questioning such interpretation of the Nodal Agency on behalf of the Utility.

## **E. QUALIFICATION AND BIDDING**

### **2.21 Notification of prequalified Applicants**

After the evaluation of Applications, the Nodal Agency on behalf of the Utility would announce a list of pre-qualified Applicants (Bidders) who will be eligible for participation in the Bid Stage on the **TCIL portal**. The Nodal Agency on behalf of the Utility would notify the pre-qualified Applicants asking to remit the required amount within a week as the cost of procuring the RFP-DBFOO documents. At the same time, the Nodal Agency on behalf of the Utility would notify the other Applicants that they have not been pre-qualified. The Nodal Agency on behalf of the Utility will not entertain any query or clarification from Applicants who fail to qualify.

### **2.22 Submission of Bids**

The Bidders will be requested to submit their Bids in the form and manner to be set out in the Bidding Documents.

Only pre-qualified Applicants shall be invited by the Nodal Agency on behalf of the Utility to submit their Bids for the Project. The Nodal Agency on behalf of the Utility is likely to provide a comparatively short time span for submission of the Bids for the Project. The Applicants are therefore advised to examine the Bidding Documents, and to carry out such scrutiny and studies as may be required for submitting their respective Bids for award of the Project. No extension of time is likely to be considered for submission of Bids pursuant to invitation that may be issued by the Nodal Agency on behalf of the Utility.

### **2.23 Proprietary data**

All documents and other information supplied by the Nodal Agency on behalf of the Utility or submitted by an Applicant to the Nodal Agency on behalf of the

Utility shall remain or become the property of the Nodal Agency on behalf of the Utility. Applicants are to treat all information as strictly confidential and shall not use it for any purpose other than for preparation and submission of their Application. The Nodal Agency on behalf of the Utility will not return any Application or any information provided along therewith.

#### **2.24 Correspondence with the Applicant**

Save and except as provided in this RFQ - DBFOO, the Nodal Agency on behalf of the Utility shall not entertain any correspondence with any Applicant in relation to the acceptance or rejection of any Application.

### 3. CRITERIA FOR EVALUATION

#### 3.1 Evaluation parameters

- 3.1.1 Only those Applicants who meet the eligibility criteria specified in Clause 2.2.2 above shall qualify for evaluation under this Section 3. Applications of firms/ consortia who do not meet these criteria shall be rejected.
- 3.1.2 The Applicant's competence and capability is proposed to be established by the following parameters:
- (a) Technical Capacity; and
  - (b) Financial Capacity

#### 3.2 Technical Capacity for purposes of evaluation

- 3.2.1 Subject to the provisions of Clause 2.2, the following categories of experience would qualify as Technical Capacity and eligible experience (the "**Eligible Experience**") in relation to eligible projects as stipulated in Clauses 3.2.3 and 3.2.4 (the "**Eligible Projects**"):

Category 1: Project experience on Eligible Projects in power sector that qualify under Clause 3.2.3

Category 2: Project experience on Eligible Projects in core sector that qualify under Clause 3.2.3

Category 3: Construction experience on Eligible Projects in power sector that qualify under Clause 3.2.4

Category 4: Construction experience on Eligible Projects in core sector that qualify under Clause 3.2.4

For the purpose of this RFQ - DBFOO:

- (i) power sector would be deemed to include generation, transmission, and distribution of electricity; and
  - (ii) core sector would be deemed to include coal mining, telecom, ports, airports, railways, metro rail, highways and bridges, industrial parks/ estates, logistic parks, pipelines, irrigation, water supply, sewerage, and real estate development.<sup>\$</sup>
- 3.2.2 Eligible Experience in respect of each category shall be measured only for Eligible Projects.
- 3.2.3 For a project to qualify as an Eligible Project under Category 1 and 2:
- a) It should have been undertaken as a project on BOT, BOLT, BOO, BOOT, or other similar basis for providing its output or services to a public sector entity or for providing non-discriminatory access to users in pursuance of its concession or contract, as the case may be. For the avoidance of doubt, a project which constitutes

<sup>\$</sup> Real estate development shall not include residential flats unless they form part of a real estate complex or township which has been built by the Applicant.

- a natural monopoly such as an airport or port should normally be included in this category even if it is not based on a long-term agreement with a public entity;
- b) the entity claiming experience should have held, in the company owning the Eligible Project, a minimum of 26% (twenty-six per cent) equity during the entire year for which Eligible Experience is being claimed;
  - c) the capital cost of the project should be more than Rs. 2000 crore (Rupees Two Thousand Crore) and
  - d) the entity claiming experience shall, during the last 5 (five) financial years preceding the Application Due Date, have (i) paid for development of the project (excluding the cost of land), and/or (ii) collected and appropriated the revenues from users availing of non-discriminatory access to or use of fixed project assets, such as revenues from transmission/distribution systems, highways, airports, ports and railway infrastructure, and/or (iii) collected and appropriated the revenues from sale of electricity produced by it, but shall not include revenues from sale or provision of goods or services such as, gas, petroleum products, telecommunications or fare/freight revenues and other incomes of the company owning the Project or revenues from sale of electricity by a distribution company.
- 3.2.4 For a project to qualify as an Eligible Project under Categories 3 and 4, the Applicant should have paid for execution of its construction works or received payments from its client(s) for construction works executed, fully or partially, during the 5 (five) financial years immediately preceding the Application Due Date, and only the payments (gross) actually made or received, as the case may be, during such 5 (five) financial years shall qualify for purposes of computing the Experience Score. However, payments/receipts of less than Rs.2000 crore (Rupees Two Thousand Crore) shall not be reckoned as payments/receipts for Eligible Projects. For the avoidance of doubt, construction works shall not include supply of goods or equipment except when such goods or equipment form part of a turn- key construction contract/ EPC contract for the project. Further, the cost of land shall not be included hereunder.
- 3.2.5 The Applicant shall quote experience in respect of a particular Eligible Project under any one category only, even though the Applicant (either individually or along with a member of the Consortium) may have played multiple roles in the cited project. Double counting for a particular Eligible Project shall not be permitted in any form.
- 3.2.6 Experience for any activity relating to an Eligible Project shall not be claimed by two or more Members of the Consortium. In other words, no double counting by a Consortium in respect of the same experience shall be permitted in any manner whatsoever.
- 3.3 Details of Experience**
- 3.3.1 The Applicant should furnish the details of Eligible Experience for the last 5 (five) financial years immediately preceding the Application Due Date.
- 3.3.2 The Applicants must provide the necessary information relating to Technical Capacity as per format at **Annex-II of Appendix-I.**
- 3.3.3 The Applicant should furnish the required Project-specific information and evidence in support of its claim of Technical Capacity, as per format at **Annex-IV of Appendix-I.**

### **3.4 Financial information for purposes of evaluation**

- 3.4.1 The Application must be accompanied by the Audited Annual Reports of the Applicant (of each Member in case of a Consortium) for the last 5 (five) financial years, preceding the year in which the Application is made.
- 3.4.2 In case the annual accounts for the latest financial year are not audited and therefore the Applicant cannot make it available, the Applicant shall give an undertaking to this effect and the statutory auditor shall certify the same. In such a case, the Applicant shall provide the Audited Annual Reports for 5 (five) years preceding the year for which the Audited Annual Report is not being provided.
- 3.4.3 The Applicant must establish the minimum Net Worth specified in Clause 2.2.2 (B), and provide details as per format at **Annex-III of Appendix-I**.

### **3.5 Pre-Qualification of Applicants**

- 3.5.1 The credentials of eligible Applicants shall be measured in terms of their Experience. The sum total of the Experience for all Eligible Projects shall be the “Aggregate Experience” of a particular Applicant. In case of a Consortium, the Aggregate Experience of each of its Members, who have an equity share of at least 26% in such Consortium, shall be summed up for arriving at the combined Aggregate Experience of the Consortium. The Applicants who are fulfilling the requirements of the RFQ - DBFOO subject to the provisions under clause 2.7 of RFQ - DBFOO will be pre-qualified by the Nodal Agency on behalf of the Utility.

## 4. FRAUD AND CORRUPT PRACTICES

- 4.1 The Applicants and their respective officers, employees, agents, and advisers shall observe the highest standard of ethics during the Bidding Process. Notwithstanding anything to the contrary contained herein, the Nodal Agency on behalf of Utility may reject an Application without being liable in any manner whatsoever to the Applicant if it determines that the Applicant has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the Bidding Process.
- 4.2 Without prejudice to the rights of the Nodal Agency on behalf of the Utility under Clause 4.1 hereinabove, if an Applicant is found by the Nodal Agency and/ Utility to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice during the Bidding Process, such Applicant shall not be eligible to participate in any tender issued by the Nodal Agency and / the Utility during a period of 2 (two) years from the date such Applicant is found by the Nodal Agency and /Utility to have directly or indirectly or through an agent, engaged or indulged in any corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice, as the case may be.
- 4.3 For the purposes of this Clause 4, the following terms shall have the meaning hereinafter respectively assigned to them:
- (a) **“corrupt practice”** means (i) the offering, giving, receiving, or soliciting, directly or indirectly, of anything of value to influence the actions of any person connected with the Bidding Process (for avoidance of doubt, offering of employment to, or employing, or engaging in any manner whatsoever, directly or indirectly, any official of the Nodal Agency and the Utility who is or has been associated in any manner, directly or indirectly, with the Bidding Process or the LOA or has dealt with matters concerning the PSA- DBFOO or arising there from, before or after the execution thereof, at any time prior to the expiry of one year from the date such official resigns or retires from or otherwise ceases to be in the service of the Nodal Agency and/ Utility, shall be deemed to constitute influencing the actions of a person connected with the Bidding Process); or (ii) save and except as permitted under sub clause (d) of Clause 2.2.1, engaging in any manner whatsoever, whether during the Bidding Process or after the issue of the LOA or after the execution of the PSA-DBFOO, as the case may be, any person in respect of any matter relating to the Project or the LOA or the PSA-DBFOO, who at any time has been or is a legal, financial or technical adviser of the Nodal Agency and/ the Utility in relation to any matter concerning the Project ;
  - (b) **“fraudulent practice”** means a misrepresentation or omission of facts or suppression of facts or disclosure of incomplete facts, in order to influence the Bidding Process;
  - (c) **“coercive practice”** means impairing or harming or threatening to impair or harm, directly or indirectly, any person or property to influence any person’s participation or action in the Bidding Process;



- (d) **“undesirable practice”** means (i) establishing contact with any person connected with or employed or engaged by the Nodal Agency and / the Utility with the objective of canvassing, lobbying or in any manner influencing or attempting to influence the Bidding Process; or (ii) having a Conflict of Interest; and
- (e) **“restrictive practice”** means forming a cartel or arriving at any understanding or arrangement among Applicants with the objective of restricting or manipulating a full and fair competition in the Bidding Process.

## 5. PRE-APPLICATION CONFERENCE

- 5.1 A Pre-Application conference of the interested parties shall be convened at the designated date, time, and place. A maximum of three representatives of each Applicant shall be allowed to participate on production of authority letter from the Applicant.
- 5.2 During the course of Pre-Application conference, the Applicants will be free to seek clarifications and make suggestions for consideration of the Nodal Agency on behalf of the Utility. The Nodal Agency on behalf of the Utility shall endeavour to provide clarifications and such further information as it may, in its sole discretion, consider appropriate for facilitating a fair, transparent, and competitive Bidding Process.

## **6. MISCELLANEOUS**

- 6.1 The Bidding Process shall be governed by, and construed in accordance with, the laws of India and the Courts in the State in which the Nodal Agency and Utility has its headquarters shall have exclusive jurisdiction over all disputes arising under, pursuant to and/ or in connection with the Bidding Process.
- 6.2 The Nodal Agency on behalf of the Utility, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to;

  - (c) pre-qualify or not to pre-qualify any Applicant and/ or to consult with any Applicant in order to receive clarification or further information;
  - (d) retain any information and/ or evidence submitted to the Nodal Agency on behalf of the Utility by, on behalf of, and/ or in relation to any Applicant; and/ or
  - (e) independently verify, disqualify, reject and/ or accept any and all submissions or other information and/ or evidence submitted by or on behalf of any Applicant.
- 6.3 It shall be deemed that by submitting the Application, the Applicant agrees and releases the Nodal Agency and the Utility, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/ or performance of any obligations hereunder and the Bidding Documents, pursuant hereto, and/ or in connection with the Bidding Process, to the fullest extent permitted by applicable law, and waives any and all rights and/ or claims it may have in this respect, whether actual or contingent, whether present or in future.

If an SPV has been incorporated by the Nodal Agency on behalf of the Utility prior to the Bid Due Date, the Parties undertake to transfer all shares of the SPV through a share purchase agreement.

**4. Role of the Parties**

- 6.4 The Parties undertake that they shall collectively hold at least 51% (fifty-one per cent) of the subscribed and paid up equity share capital of the SPV at all times until the second anniversary of the commercial operation date of the Project.
- 6.5 The Parties undertake that they shall comply with all equity lock-in requirements set forth in the PSA-DBFOO.

#### **OFFICE MEMORANDUM**

Sub: Guidelines for qualification of Bidders seeking to acquire stakes in Public Sector Enterprises through the process of disinvestment

Government has examined the issue of framing comprehensive and transparent guidelines defining the criteria for bidders interested in PSE-disinvestment so that the parties selected through competitive bidding could inspire public confidence. Earlier, criteria like net worth, experience etc. used to be prescribed. Based on experience and in consultation with concerned departments, Government has decided to prescribe the following additional criteria for the qualification/disqualification of the parties seeking to acquire stakes in public sector enterprises through disinvestment:

- (a) In regard to matters other than the security and integrity of the country, any conviction by a Court of Law or indictment/ adverse order by a regulatory authority that casts a doubt on the ability of the bidder to manage the public sector unit when it is disinvested, or which relates to a grave offence would constitute disqualification. Grave offence is defined to be of such a nature that it outrages the moral sense of the community. The decision in regard to the nature of the offence would be taken on case-to-case basis after considering the facts of the case and relevant legal principles, by the Government of India.
- (b) In regard to matters relating to the security and integrity of the country, any charge-sheet by an agency of the Government/ conviction by a Court of Law for an offence committed by the bidding party or by any sister concern of the bidding party would result in disqualification. The decision in regard to the relationship between the sister concerns would be taken, based on the relevant facts and after examining whether the two concerns are substantially controlled by the same person/ persons.
- (c) In both (a) and (b), disqualification shall continue for a period that Government deems appropriate.

- (d) Any entity, which is disqualified from participating in the disinvestment process, would not be allowed to remain associated with it or get associated merely because it has preferred an appeal against the order based on which it has been disqualified. The mere pendency of appeal will have no effect on the disqualification.
- (e) The disqualification criteria would come into effect immediately and would apply to all bidders for various disinvestment transactions, which have not been completed as yet.
- (f) Before disqualifying a concern, a Show Cause Notice why it should not be disqualified would be issued to it and it would be given an opportunity to explain its position.
- (g) Henceforth, these criteria will be prescribed in the advertisements seeking Expression of Interest (EOI) from the interested parties. The interested parties would be required to provide the information on the above criteria, along with their Expressions of Interest (EOI). The bidders shall be required to provide with their EOI an undertaking to the effect that no investigation by a regulatory authority is pending against them. In case any investigation is pending against the concern or its sister concern or against its CEO or any of its Directors/ Managers/ employees, full details of such investigation including the name of the investigating agency, the charge/ offence for which the investigation has been launched, name and designation of persons against whom the investigation has been launched and other relevant information should be disclosed, to the satisfaction of the Government. For other criteria also, a similar undertaking shall be obtained along with EOI.

## **APPENDIX –VIII**

### **Indicative E-Reverse Bidding Steps to be Followed**

#### **Steps Shall be Followed (Indicative and shall be finalized during issuance of RFP):**

1. Mock E-Auction to be conducted for the eligible bidders.
2. E-Reverse Bidding shall be conducted based on ceiling tariff determined in the preceding round. **(Ceiling Tariff in this context means the Lowest (L1) tariff discovered through the submission of sealed bids by all the Bidders and the bidders shall need to quote below the Ceiling Tariff during e- reserve bidding round).**
3. The Bidders will have the option of reducing the Total Tariff quoted by them at e-Tender Stage for the following components:
  - a. Fixed Charge to be considered as a variable input for each round.
  - b. Variable Charge (including Coal Washing) to be considered as variable input for each round.
4. The respective bids shall be decrements of 1 (one) paise or multiples thereof during the E-reverse bidding process **[SPO (Subsequent Price Offered)]**.
5. The L1 bidder shall be determined based on the Lowest total Tariff discovered through the E-Reverse Bidding process including tax component as applicable.
6. In case there is no further bids submitted in e-reverse auction, then the L-1 bidder as per **[IPO(Initial Price Offered)]** round shall stand valid.
7. Tax component on Variable charge shall be added separately after this round.
