NOTIFICATION

In exercise of the power conferred by clause (3) of Article 166 of the Constitution of India, the Governor is pleased hereby to make the following amendments in the West Bengal Rules of Business, as subsequently amended (hereinafter referred to as the said rules):-

Amendments

- (1) In the First Schedule to the said Rule, under the heading "Departments",
 - (i) for the item "XXVI. Department of Power and Non-conventional Energy Sources" substitute the following item "XXVIA. Department of Power";
 - (ii) after item XXVIA, insert the following item and entries "XXVIB. Department of Non-conventional and Renewable Energy Sources";
 - (iii) after item LXIV, insert the following item and entries "LXV. Department of Public Enterprises and Industrial Reconstruction".
- (2) In the First Schedule to the said rules, under the heading "Allocation of business among departments",
 - (i) Under sub-heading "VIII. Department of Industry, Commerce and Enterprises" in Part I, omit item 3, item 4, item 5, item 9 and item 10 and entries relating thereto;
 - (ii) For sub-heading "XXVI. Department of Power and Non-conventional Energy Sources" and items and entries appearing thereunder substitute the following sub-heading, item and entries:

"XXVIA. DEPARTMENT OF POWER

1. Formulation and implementation of policies and projects relating to power generation, development and utilisation and rural electrification, except the matter relating to non-conventional and renewable energy.
2. Co-ordination between departments and agencies of the State and Union Governments concerned with policies and schemes relating to power.

3. To govern the West Bengal Industrial Renewal Scheme, 2001 as envisaged in items (1) (a) and (1) (b) under this part;
4. To govern and administer the West Bengal Relief Undertakings (Special Provision) Act, 1972;
