

APPOINTMENT TO THE POST OF MEMBER (LAW) OF WEST BENGAL ELECTRICITY REGULATORY COMMISSION

Applications are invited from eligible persons for appointment to the position of Member (Law) of the West Bengal Electricity Regulatory Commission. In terms of Section 84(1) of the Electricity Act, 2003, the Member of Commission shall be a person of ability, integrity, and standing who has adequate knowledge and has shown capacity in dealing with problems relating to Engineering, Finance, Commerce, Economics, Law or Management.

In compliance with the judgement of the Hon'ble Supreme Court, dt. 12.04.2018 in Civil Appeal No. 14697 of 2015, the instant vacancy requires a person, who is , or has been holding a Judicial Office or is a person possessing professional qualification with substantial experience in the practice of Law, who has the requisite qualifications to have been appointed as a Judge of the High Court or a District Judge.

A person having any financial or any other interest that is likely to affect prejudicially his / her function as a Member of the Commission is not eligible.

In terms of Section 89(1) of the Electricity Act, 2003, a Member, shall hold Office for a terms of 5(Five) years from the date he/she joins the Office or till he/she attains 65(Sixty five) years of age, whichever is earlier.

The salary, allowances and other terms and conditions of service of the Member shall be governed by the West Bengal Electricity Regulatory Commission (Salary, Allowances and Conditions of service of the Chairperson & other Member etc) Rules, 2004 as amended vide memo no. 28-PO/O/III/3R-07/2003(Pt), dated 14.02.2007.
