ORDER

The present bid with Ref no. 305-POW-29014/1/2022 dt. 24-02-2023 for selection of a developer for installation of Bandu Pumped Storage Project (PSP) with proposed capacity of 900 MW through DBFOT Concessionaire (Design, Build, Finance, Operate, Transfer) mode was uploaded in the e-procurement portal (wbtenders.gov.in) and is valid till 27-09-2023.

2. Subsequently, Ministry of Power, Govt. of India vide their O.M. No. F No. 15-14/9/2022-H-II (Part) dt. 10th April,2023 introduced certain guidelines relating to execution of PSP which have some intrinsic differences with the present Bandu PSP Bid document.

3. Now, on assessment of the matter, the undersigned by the order of the Governor has decided to cancel the present bid as ibid in para 1 above due to administrative ground until further order.


