
CIRCULAR

In pursuance of memo no. 101-PO/P/C-II/1BN-09/2015 dated 14.09.16 of Joint Secretary, Power & NES Deptt., GOWB, a Grievance Monitoring System has been set up for redressal of grievance relating to service, compensation on land etc. and other matters. Sri Siddhartha Pal, Manager (PS), Corporate Vigilance Cell has been nominated as the Nodal Officer for this purpose.

Procedure for attending and disposing of grievance received at Grievance Monitoring System is stated below :-

1. Grievance received related to corporate as well as plants will be forwarded by the Nodal Officer to the concerned officer of respective department of the Corporate Office.
2. Such official of respective department of corporate office shall prepare a suitable reply to the grievance forwarded to him. If the grievance is related to plants, information if required, may be sought from the plants by the departmental officer of the corporate office. However, the final report should be prepared by the departmental officer of the corporate office for sending it to the Nodal Officer.
3. On receipt of reply from the departmental officer of the corporate office, Nodal Officer, Corporate Vigilance Cell will inform the petitioner Power & NES Deptt. accordingly with the approval of the CVO.
