

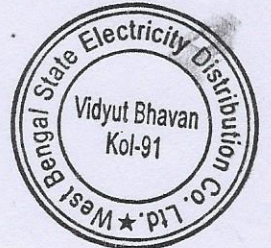
Qualification: Bachelor Degree in Civil Engineering

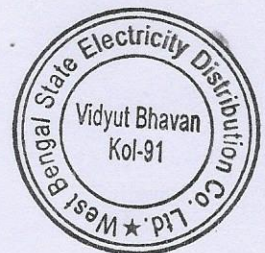


