1. All the Services of this Directorate are available Online at the web portal <https://edistrict.wb.gov.in>.
2. To streamline the Online process, it is hereby informed that all existing holders of Workman's Permit, Electrical Supervisor's Certificate of Competency, National Supervisor Certificate, Contractor's License etc. under West Bengal Licensing Board (Electrical) should update the legacy data entry in the above web portal by the end of 31st March, 2020, failing which, the Services could not be rendered in the off-line mode by the Directorate of Electricity, Govt. of West Bengal.
3. It is further informed that from 1st April, 2020 all applications for the Services rendered by this Directorate for the above stated purposes shall be submitted through Online mode only at <https://edistrict.wb.gov.in>, as off-line Services shall be discontinued from 1st April, 2020.


